2135.	MINUTES OF THE MEETING HELD ON 26TH JANUARY 2009. The Minutes of the Meeting, having been previously circulated, were then duly signed as a true record of events. All agreed except Cllr. Otter.	
2136.	DECLARING ANY PERSONAL OR PREJUDICIAL INTERESTS. Cllrs. Otter, Phillips and Dixon declared an interest in Item 19 on the Agenda – Village Design Statement. Cllrs. Phillips and Rilstone declared an interest in Item 10 on the Agenda – Stock Library and Stock Heritage Society. Cllrs. Dixon and Hawkes declared prejudicial interests in Planning Application Nos. 08/02137/FUL and 08/02138/CAC – 51 Mill Road.	
2137.	POLICE MATTERS. Cllr. Grundy reported that PCSO Kay Fleming was currently on sick leave following an operation. PCSO Susan Sullivan was looking after Stock in PCSO Fleming’s absence. Cllr. Woodward reported that car tyres had been slashed and a break-in in Mill Road. Cllr. Grundy advised that the break-in had been reported to the Police. Cllr. Woodward to speak to owner of the car advising him to report the matter to the Police if he had not already done so. Cllr. Dixon reported that two car windows had also been smashed in Mill Road. The Chairman stressed that all crimes must be reported to the Police. Cllr. Rilstone reported that a car was straddling the pavement outside Lavender Cottage, opposite The Hoop. Clerk to report matter to Police.	CLERK
2138.	MATTERS ARISING FROM THE MINUTES. Julie Ebbage of Highways had advised the Clerk that due to poor weather conditions there has been no further action on highway matters and in future updates will only be received on a quarterly basis. Tree Warden Scheme – Cllr. Woodward advised that tree planting would be carried out on the 6 th March in conjunction with Stock Primary School. 15 children would be taking part and the meeting place was at the Village Hall at 9.15am. Cllr. Woodward said that he would pass the papers onto Cllr. Johnson and that she would take charge of the day. Trees are also to be planted in Mill Road, Brookmans Road and Honeypot Lane. Cllrs. Rilstone, Dixon and Millernas offered to help on the day. Cllr. Grundy suggested organising a photographer but was advised to speak to the Headmaster first as there are now strict guidelines regarding taking photographs of school children. Parish Paths Partnership (P3) – Cllr. Finch had inspected the broken stile and advised that it does not constitute a danger but he has reported the matter to Shirley Lucas at Essex County Council. <p>Listing of War Memorial – Nothing further to report.</p> <p>Damaged Honeypot Lane Street Name Plate – Nothing to report.</p> <p>Car Park on the Common, Ponding in Common Road and Essex County Council’s Community Initiatives Fund – It was reported that Highways had cancelled the drainage work due to running out of funds in the Budget and the matter had been postponed to the new financial year. The Clerk had written a letter of complaint to Highways. Cllr. Grundy had also written to Essex County Council regarding the matter. Cllr. Woodward reported that his contractors had started work on the car parking area. The Clerk had written to the Cricket Club, Bowls Club and Montessori advising them that the area was out of bounds until further notice. A donation of £30.00 had been received from the Montessori towards the work being carried out to the car parking area. The Bowls Club are meeting in March and the matter of a donation will be put on the Agenda for discussion. Cllrs. Woodward, Johnson and Grundy had attended a site meeting with Mr Vale from Highways to look at an imminent solution. It was agreed to dig a ditch from the Common car park to the corner of the common by The Nook to disperse the water and hopefully prevent further flooding. The Chairman stated that it had been a very useful meeting. The Chairman advised that there will be an increase in the cost of the work due to the digging of the ditch.</p> <p>Speed Indicator Signs – The Chairman reported that the posts had been erected.</p> <p>Posts Outside Compass Green – Nothing to report.</p> <p>Maintenance Works to area in the vicinity of Furze Lane junction at the southern end of the Lane – Julie Ebbage of Highways advised the Clerk that the recycling/retread process is an insitu surfacing process which recycles the existing materials and is mixed with an emulsion to hold it together. Highways have used this on other locations within Essex and found it to be an economical process for routes similar to Brittons Lane. The end product provides a durable reshaped surface for vehicles to travel over causing minimal disruption to all road users. Clerk to advise Mrs Ebbage that the Parish Council are happy for her to proceed with the work.</p> <p>Re-Marking Zebra Crossing in High Street – Nothing to report.</p> <p>Broken Strut Under the Seat by the School - Bob Hale dealing with matter. Chairman agreed to chase matter.</p> <p>Car Parking at The Village Hall – The Chairman advised that a meeting was pending with the Village Hall Management Committee. Chairman to report back at next meeting.</p> <p>Water outside 122-124 Mill Road – Nothing to report.</p> <p>State of Back Lane and Brookmans Road and non-existent turf – EDF engineers were due to be sent to the site last week. Cllr. Phillips advised that no work had been carried out. Clerk to contact EDF. Cllr. Millernas had written to Highways advising that the drains are blocked along the lane and as a result it is flooded all the time. Cllr. Millernas also reported the blocked drain at the bend of Vernon Corner/Back Lane and Rectory Lane.</p> <p>Overgrown foliage near the Zebra Crossing – Nothing to report.</p> <p>Ingatestone Road junction with Honeypot Lane and Timber Bollard replacement outside Pembroke House, Ingatestone Road – Cllr.
